

Who Else is Investing in the Algarve?

In the first half of 2023, Portugal's hotel sector surged in importance, comprising 40% of total investment, highlighting the nation's ongoing prominence in global investments and the central role of tourism. The Algarve, notably Vilamoura, continued its steady growth, drawing international attention and investors. A notable acquisition occurred in September 2023 when Pestana acquired Vila Sol Resort, strengthening their position as the owner of this development, including a 5-star hotel, two golf courses, and land for development, sold for approximately €43 million.



In the same month, American investment giant Blackstone acquired Cascade Wellness Resort in Lagos for €50 million. Perched on the cliffs of Ponta da Piedade, this 5-star resort features 108 spacious rooms, 58 apartments, 4 villas, three restaurants, two bars, and comprehensive amenities, making it a versatile destination for leisure and events. Blackstone also owns Domes Lake Algarve in Vilamoura.

In June, British group Arrow purchased the company owning Hilton Vilamoura - Cascatas Golf Resort & SPA and Vilamoura Garden, both located in the Algarve. Additionally, in May 2023, Amendoeira Golf Resort was acquired by the Rolear Group, marking the culmination of five years of revitalization efforts, resulting in the sale of 241 properties. The sale of Palmares Ocean Living and Golf in Lagos, which includes 103 villas, 357 apartments, two five-star hotels, and a 27-hole golf course, is currently under negotiation.

Another major brand coming to the Algarve is the Hard Rock Hotel. The new development will be located near Praia do Vau, Portimão. The property, set to begin construction in early 2024 and open in Summer 2026, will have around 275 luxurious rooms and suites and an additional 150 branded serviced apartments.
